**ELIGIBILITY:** The **Life's A Journey Sweepstakes** (the "Sweepstakes") is open only to individuals who are (a) legal residents of the fifty (50) United States and the District of Columbia, and (b) at least eighteen (18) years of age and the age of majority in their state of residence at the time of entry. Employees of Jambu and their affiliate companies, or other companies associated with the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of any such employee, are not eligible to enter.
